

By virtue of the powers vested in me in terms of Section 28 (1)(b) of the Water Services Act, 1997 (Act No. 108 of 1997) I, Mr Senzo Mchunu, in my capacity as the Minister of Water and Sanitation, hereby give notice to:

- a) Change the name of Umgeni Water to uMngeni - uThukela Water, effective 01 July 2023.
- b) The name change, i.e., "uMngeni - uThukela Water" incorporates the geographic area of operations of Umgeni Water and the former Mhlathuze Water.




